

Clinical Policy: Nilotinib (Tasigna, Danziten)

Description

Nilotinib (Tasigna[®], Danziten[™]) is a kinase inhibitor.

FDA Approved Indication(s)

Tasigna and Danziten are indicated for the treatment of:

- Adult (*both Tasigna and Danziten*) and pediatric patients greater than or equal to 1 year of age (*Tasigna only*) with newly diagnosed Philadelphia chromosome positive chronic myeloid leukemia in chronic phase (Ph+ CML-CP).
- Adult patients with Ph+ CML-CP and accelerated phase (Ph+ CML-AP) CML resistant or intolerant to prior therapy that included imatinib.

Tasigna is also indicated for the treatment of pediatric patients greater than or equal to 1 year of age with Ph+ CML-CP and CML-AP resistant or intolerant to prior tyrosine-kinase inhibitor (TKI) therapy.

Policy/Criteria

Provider must submit documentation (such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.

It is the policy of health plans affiliated with Centene Corporation[®] that Tasigna and Danziten are **medically necessary** when the following criteria are met:

I. Initial Approval Criteria**A. Chronic Myeloid Leukemia** (must meet all):

1. Diagnosis of Ph+ (BCR-ABL1-positive) CML;
2. Prescribed by or in consultation with an oncologist or hematologist;
3. Member meets one of the following (a or b):
 - a. Tasigna: Age \geq 1 year;
 - b. Danziten: Age \geq 18 years;
4. Member does not have the following mutations: T315I, Y253H, E255K/V, F359V/C/I;
5. One of the following (a or b):
 - a. Member has contraindication, intolerance, or disease progression on imatinib;
 - b. Request is for treatment associated with cancer for a State with regulations against step therapy in certain oncology settings (*see Appendix D*);

6. For brand Tasigna or Danziten requests, member must use generic nilotinib, if available, unless contraindicated or clinically significant adverse effects are experienced;
7. Request meets one of the following (a, b, or c):*
 - a. Tasigna: Dose does not exceed 800 mg per day;
 - b. Danziten: Dose does not exceed 380 mg per day;
 - c. Dose is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (*prescriber must submit supporting evidence*).

**Prescribed regimen must be FDA-approved or recommended by NCCN*

Approval duration:

Medicaid/HIM - 6 months

Commercial - 12 months or duration of request, whichever is less

B. Acute Lymphoblastic Leukemia (off-label) (must meet all):

1. Diagnosis of Ph⁺ (BCR-ABL1-positive) acute lymphoblastic leukemia (ALL);
2. Request is for Tasigna;
3. Prescribed by or in consultation with an oncologist or hematologist;
4. Age \geq 15 years;
5. Member does not have the following mutations: T315I, Y253H, E255K/V, F359V/C/I, G250E;
6. One of the following (a or b):
 - a. Member has contraindication, intolerance, or disease progression on imatinib;
 - b. Request is for treatment associated with cancer for a State with regulations against step therapy in certain oncology settings (*see Appendix D*);
7. For brand Tasigna requests, member must use generic nilotinib, if available, unless contraindicated or clinically significant adverse effects are experienced;
8. Dose is within FDA maximum limit for any FDA-approved indication or is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (*prescriber must submit supporting evidence*).*

**Prescribed regimen must be FDA-approved or recommended by NCCN*

Approval duration:

Medicaid/HIM - 6 months

Commercial - 12 months or duration of request, whichever is less

C. Gastrointestinal Stromal Tumor (off-label) (must meet all):

1. Diagnosis of gastrointestinal stromal tumor (GIST, a soft tissue sarcoma);
2. Request is for Tasigna;
3. Prescribed by or in consultation with an oncologist;
4. Age \geq 18 years;
5. Failure of imatinib, Qinlock[®], Sutent[®], or Stivarga[®], unless clinically significant adverse effects are experienced or all are contraindicated;
**Prior authorization may be required.*
6. For brand Tasigna requests, member must use generic nilotinib, if available, unless contraindicated or clinically significant adverse effects are experienced;
7. Dose is within FDA maximum limit for any FDA-approved indication or is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (*prescriber must submit supporting evidence*).*

**Prescribed regimen must be FDA-approved or recommended by NCCN*

Approval duration:

Medicaid/HIM - 6 months

Commercial - 12 months or duration of request, whichever is less

D. Myeloid/Lymphoid Neoplasms (off-label) (must meet all):

1. Diagnosis of lymphoid, myeloid, or mixed lineage neoplasms with eosinophilia and ABL1 rearrangement in blast or chronic phase;
2. Request is for Tasigna;
3. Prescribed by or in consultation with an oncologist or hematologist;
4. Age \geq 18 years;
5. One of the following (a or b):
 - a. Member has contraindication, intolerance, or disease progression on imatinib;
 - b. Request is for treatment associated with cancer for a State with regulations against step therapy in certain oncology settings (*see Appendix D*);
6. For brand Tasigna requests, member must use generic nilotinib, if available, unless contraindicated or clinically significant adverse effects are experienced;
7. Dose is within FDA maximum limit for any FDA-approved indication or is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (*prescriber must submit supporting evidence*).*

**Prescribed regimen must be FDA-approved or recommended by NCCN*

Approval duration:

Medicaid/HIM - 6 months

Commercial- 12 months or duration of request, whichever is less

E. Off-Label Indications (must meet all):

1. Diagnosis of one of the following (a or b):
 - a. Pigmented villonodular synovitis/tenosynovial giant cell tumor;
 - b. KIT-positive metastatic or unresectable melanoma as second-line or subsequent therapy (i.e., following BRAF-targeted therapy);
2. Request is for Tasigna;
3. Prescribed by or in consultation with an oncologist or hematologist;
4. Age \geq 18 years;
5. One of the following (a or b):
 - a. Member has contraindication, intolerance, or disease progression on imatinib;
 - b. Request is for treatment associated with cancer for a State with regulations against step therapy in certain oncology settings (*see Appendix D*);
6. For brand Tasigna requests, member must use generic nilotinib, if available, unless contraindicated or clinically significant adverse effects are experienced;
7. Dose is within FDA maximum limit for any FDA-approved indication or is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (*prescriber must submit supporting evidence*).*

**Prescribed regimen must be FDA-approved or recommended by NCCN*

Approval duration:

Medicaid/HIM – 6 months

Commercial – 12 months or duration of request, whichever is less

F. Other diagnoses/indications (must meet 1 or 2):

1. If this drug has recently (within the last 6 months) undergone a label change (e.g., newly approved indication, age expansion, new dosing regimen) that is not yet reflected in this policy, refer to one of the following policies (a or b):
 - a. For drugs on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the no coverage criteria policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.33 for health insurance marketplace, and CP.PMN.255 for Medicaid; or
 - b. For drugs NOT on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the non-formulary policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.103 for health insurance marketplace, and CP.PMN.16 for Medicaid; or
2. If the requested use (e.g., diagnosis, age, dosing regimen) is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized) AND criterion 1 above does not apply, refer to the off-label use policy for the relevant line of business: CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid.

II. Continued Therapy

A. All Indications in Section I (must meet all):

1. Currently receiving medication via Centene benefit, or documentation supports that member is currently receiving Tassigna or Danziten for a covered indication and has received this medication for at least 30 days;
2. Member is responding positively to therapy;
3. For Danziten requests, member has diagnosis of CML;
4. For brand Tassigna or Danziten requests, member must use generic nilotinib, if available, unless contraindicated or clinically significant adverse effects are experienced;
5. If request is for a dose increase, request meets one of the following (a, b, or c):*
 - a. Tassigna: New dose does not exceed 800 mg per day;
 - b. Danziten: New dose does not exceed 380 mg per day;
 - c. New dose is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (*prescriber must submit supporting evidence*).

**Prescribed regimen must be FDA-approved or recommended by NCCN*

Approval duration:

Medicaid/HIM - 12 months

Commercial - 12 months or duration of request, whichever is less

B. Other diagnoses/indications (must meet 1 or 2):

1. If this drug has recently (within the last 6 months) undergone a label change (e.g., newly approved indication, age expansion, new dosing regimen) that is not yet reflected in this policy, refer to one of the following policies (a or b):
 - a. For drugs on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the no coverage criteria policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.33 for health insurance marketplace, and CP.PMN.255 for Medicaid; or

- b. For drugs NOT on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the non-formulary policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.103 for health insurance marketplace, and CP.PMN.16 for Medicaid; or
- 2. If the requested use (e.g., diagnosis, age, dosing regimen) is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized) AND criterion 1 above does not apply, refer to the off-label use policy for the relevant line of business: CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid.

III. Diagnoses/Indications for which coverage is NOT authorized:

- A. Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policies – CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid, or evidence of coverage documents.

- Contraindication(s): hypokalemia, hypomagnesemia, long QT syndrome

NV	Yes	Stage 3 and stage 4 cancer patients for a prescription drug to treat the cancer or any symptom thereof of the covered person
